NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

(1) Creation of a narthex, entailing disposal of 6no pews from the southeast end of nave, introduction of glazed screens/doors under the gallery and glazed lobby to entrance, relocation of the font to the south aisle, modifications to the ceiling/gallery underside, and new floor finishes;

(2) Introduction of new facilities, including an accessible WC adjacent to the main entrance and a kitchenette in the east corner with servery into nave;

(3a) Introduction of stainless steel handrails to the exterior of the southwest entrance;

(3b) Introduction of accessible, waymarking signage from the main entrance to the southeast entrance;

(4) Minor improvements to the area of boiler room, including introduction of metal gate, and removal of servery counter in south aisle;

(5) Installation of 4no halo style heaters to the northwest end of nave, and other minor lighting, heating and electrical upgrades to the new narthex and facilities.
